Notice is hereby given that sealed bids will be received at the Logan County Commissioners Office, 117 E. Columbus Avenue, Suite 100, Bellefontaine, Ohio 43311 until 10:30 a.m. Ohio Standard Time, Thursday, October 2, 2014 for furnishing "**BULK TREATED HIGHWAY SALT**" delivered, as ordered, in one hundred (100) ton lots, without blower, to the Logan County Highway Department and/or the City of Bellefontaine Street Department.

The tonnage for the time period from January 15, 2015 to May 1, 2015 is 700 tons for Logan County Engineer and 800 tons for the City of Bellefontaine.

Each bid shall be submitted on forms furnished by the Logan County Commissioners in a sealed envelope marked "**HIGHWAY SALT**" on the outside.

Each bidder shall be required to file with his bid, a certified check or cashiers check for an amount equal to five (5%) percent of his bid, payable to the Treasurer of Logan County, or a bid bond equal to five (5%) percent of his bid.

The successful bidders shall furnish the Logan County Highway Department and/or the Bellefontaine Street Dept. with a MSDS prior to the first shipment. The successful bidder shall be required to provide them with any changes during the contract period.

The Logan County Commissioners and/or the City of Bellefontaine reserve the right to reject any or all bids and to waive any defects in the bids.

Bids will be awarded to the lowest and best bidder, based on the grand total of the unit price bid.
