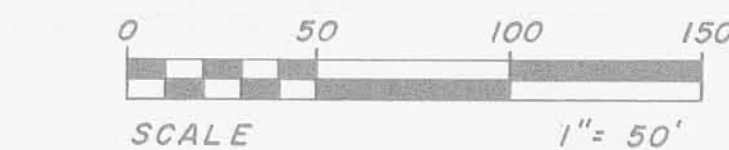


BROOKWOOD ADDITION NO. 3

The Subscriber, L. P. Z. The roads and drives shown on the annexed plat and not heretofore dedicated, are hereby dedicated to public use as such.

Lot lines are shown as solid lines. The dashed lines marked Building Line indicate the distances houses and all other structures, including garages and porches, must be set back from all roads and drives.

Easements shown on the plat are for the construction, operation, and maintenance of public utilities and storm drainage and where necessary are for the construction, operation and maintenance of service connections to adjacent lots. Unless otherwise shown, easements are 10 feet wide, being 5 feet wide each side of lot lines.
