THAT WE CLARA SMITH OF RUSSELS POINT OHIO, OWNERS AND PROPRIETORS
OF THE LANDS DESCRIBED ON THE FOREGOING PLAT SITUATED IN SEC. 36 TOWN 6 RANGE 8 AND
ALSO IN SEC. 1 TOWN 7 RANGE 8 IN WASHINGTON TOWNSHIP, LOGAN COUNTY OHIO, DESIRING TO SUB-
DIVIDE SAID LAND INTO LOTS AS SHOWN ON THE FOREGOING PLAT, HAVE CAUSED A
SURVEY AND THIS PLAT TO BE MADE, AND WE DO HEREBY GIVE, GRANT, AND DEDICATE THE
