SURVEYOR'S CERTIFICATE

I, Clair A. Inskeep, do hereby certify the annexed plat is a true representation of FERNWOOD NUMBER TWO as surveyed by me in October and November 1945. The said subdivision is a part of VIRGINIA MILITARY SURVEY NUMBER 13393 in Richland Township, Logan County, Ohio.

The said subdivision is located on both sides of STATE HIGHWAY NUMBER 920 and extends from station 92 plus 27.25 to station 97 plus 62.19 of said highway.

All dimensions on the plat are in feet. All lot lines are at right angles or are parallel to the street lines except as indicated on the plat. A is used to represent the central angle; R to represent the radius; T to represent the tangent; C to represent the chord. The frontage shown on each curvilinear lot is the length of the chord for that lot.

○ represents a state Highway Department right of way marker which is a concrete monument six inches in diameter and three feet long;

○ represents an iron pipe set. ○ represents a 3/4 inch iron bar found. A wood stake 2 inches by 2 inches by 18 inches long was set at each lot corner.

The area contained within the plat is 4.09 acres.
