DESCRIPTION

Indian Lake West Side Sub-Division Number 1 is a part of the Northwest Quarter of Section 23 Township 6, Range 8, Stokes Township, Logan County, Ohio and is described as follows: Beginning at the intersection of the southerly Waterline of Blackhawk Channel with the Easterly Right-of-Way line of State Route 69: thence South $01^{\circ} 57'$ West 222.0'; thence South $54^{\circ} 30'$ East 548.5' to a point; Thence on a curve to the Southwest with a radius of 650' a distance of 137'; Thence North $85^{\circ} 33'$ West 371.4' to the said Right-of-Way of State Route 69; Thence South $01^{\circ} 57'$ West 190' to the North right-of-way line of State Route 365; Thence South $85^{\circ} 33'$ East 494.9' to a stake; Thence North $40^{\circ} 32'$ East 220.92'; Thence North $52^{\circ} 31'$ East 199.5'; Thence North $54^{\circ} 30'$ West 942.6' to the place of beginning and containing 5.7 Acres more or less.
