

SURVEYOR'S CERTIFICATE

The annexed plat correctly represents O'Connor Allotment, lots number 35 to 91 inclusive, of parts of Virginia Military Survey numbers 9968 and 13393 in Richland Township, Logan County, Ohio. The dimensions are indicated in feet and decimals of a foot. All curved lines indicated are arcs of circles. Where reference is made to curved lines the Greek letter Δ is used to indicate the central angle; the letter T, the tangent distance; the letter C, the chord distance. Iron pipe were placed at each lot corner and at the beginning and ending of each curve and at other points indicated.

The area included in Virginia Military Survey number 9968 is .32 acres and the area included in Virginia Military Survey number 13393 is 14.22 acres.
