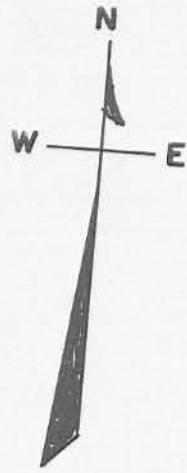
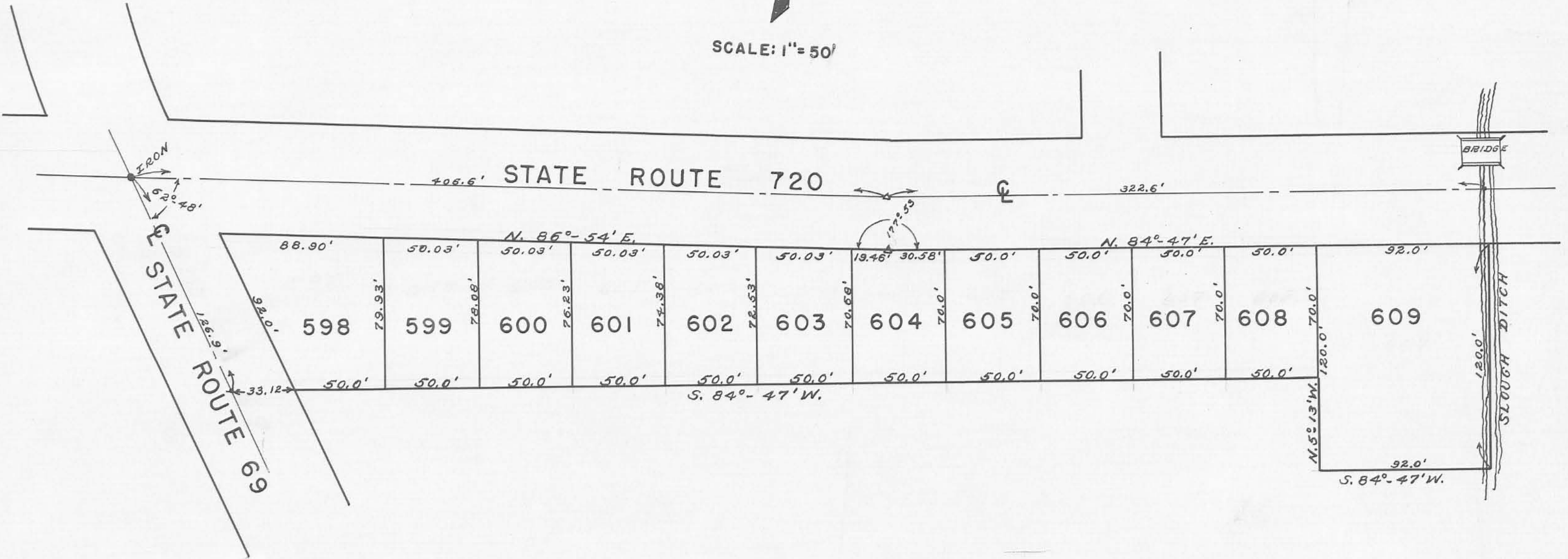


PLAT CABINET A
