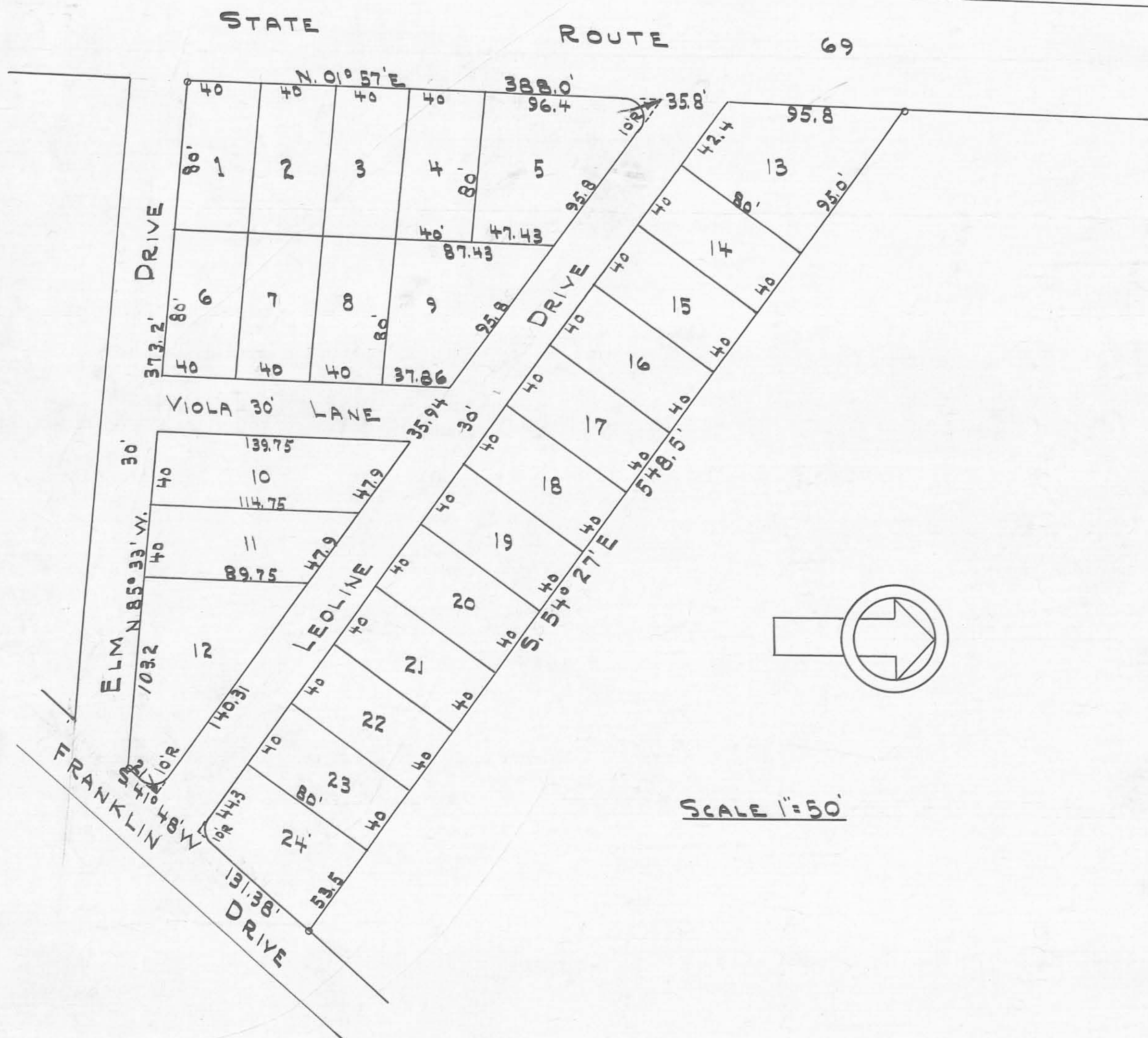


INDIAN LAKE WEST SIDE SUB-DIVISION NUMBER 3



DESCRIPTION.

INDIAN LAKE WEST SIDE SUB-DIVISION NUMBER 3 IS A PART OF THE NORTHWEST QUARTER OF SECTION 23, TOWNSHIP 6, RANGE 8 STOKES TOWNSHIP, LOGAN COUNTY OHIO AND DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTH EAST CORNER OF STATE ROUTE 69 AND ELM DRIVE IN SAID SECTION AS THE SAME IS RECORDED IN PLAT C VOLUME 3 PAGE 59 IN THE OFFICE OF THE LOGAN COUNTY RECORDER AND KNOWN AS INDIAN LAKE WEST SIDE SUB-DIVISION No. 1: THENCE N. 01° 57' E. ALONG THE EAST LINE OF STATE ROUTE 69- 388 FEET TO AN IRON PIPE: THENCE S. 54° 27' E. 548.5 FEET TO THE WEST LINE OF FRANKLIN DRIVE: THENCE S. 41° 48' W. ALONG THE SAID WEST LINE OF SAID FRANKLIN DRIVE 131.38 FEET TO THE NORTH LINE OF ELM DRIVE: THENCE N. 85° 33' W. ALONG SAID NORTH LINE 373.2 FEET TO THE PLACE OF BEGINNING AND CONTAINING 2.482 ACRES OF LAND, BE IT THE SAME, MORE OR LESS.
