

AN ORDINANCE VACATING THAT CERTAIN PUBLIC EAST-WEST ALLEY BETWEEN LOTS 1901 AND 1934 ON THE NORTH AND LOT 1902 AND LOT 1935 ON THE SOUTH, IN THE CITY OF BELLEFONTAINE, LAKE TOWNSHIP, LOGAN COUNTY, OHIO.

ORDINANCE NO. 23.33

WHEREAS, a petition by Logan Commercial LLC, owning lots in the immediate vicinity of the hereinafter described alley was duly presented to Planning Commission and Council praying that the hereinafter described alley be vacated; and

WHEREAS, waivers and consents to the proposed alley vacation have been filed by all abutting lot owners and notice of the intention of this Council to vacate said alley is not required pursuant to Ohio Revised Code Section 723.06; and

WHEREAS, the Planning Commission of the City of Bellefontaine has recommended that Council grant said petition; and

WHEREAS, this Council is satisfied that there is good cause for such vacation; that such vacation will not be detrimental to the general interest of the City; and, therefore, ought to be made.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Bellefontaine, Ohio:

SECTION I: That 15 foot wide and approximately 285 foot long East-West public alley of Iron City Addition (Plat Cabinet A, Slide 29), lying between City Lots 1901 and 1934 on the North and City Lot 1902 and Lot 1935 on the South, as more particularly outlined on Exhibit A attached hereto and incorporated herein, in the City of Bellefontaine, be, and the same hereby are, vacated; reserving, however, unto the City of Bellefontaine easement rights for any and all municipal purposes. Parcel # 17-106-08-03-014-000 (Lots 1932, 1933 and 1934), Parcel # 17-106-08-03-013-000 (Pt. Lot 1935), Parcel # 17-106-08-03-004-000 (Lot 1902), Parcel # 17-106-08-03-003-000 (Lot 1901) and Parcel #17-106-08-03-013.001 (Part Lot 1935).

SECTION II: That the plat accompanying said petition be referred to the Clerk of this Council for filing with the Logan County Auditor and Recorder as provided by Ohio Revised Code Sections 711.39 with any accompanying fee.

SECTION III: This Ordinance shall take effect at the earliest time allowable by law.


