Transanauen	AN ORDINANCE VACATING A PORTION OF LIMA STREET, VILLAGE OF LAKEVIEW, LOGAN COUNTY, OHIO.
	WHEREAS, the Lakeview Village Council, upon a hearing in accordance with the Ohio Revise Code, was satisfied that there is good cause for such vacation; that such vacation will not be detrimental to the general interests of the Village; and, therefore, ought to be granted; and
	WHEREAS, there is no opposition to the vacation of the street as described below; and
	NOW, THEREFORE, BE IT ORDAINED, by the Village Council of Lakeview, Ohio;
	SECTION I: Situated in the State of Ohio, County of Logan, Township of Stokes and Village of Lakeview, Being that 30-feet wide by approximately 160 feet long portion of Lima Street south of Grove Avenue, west of lots 233, 234, 235 and 236 and east of lots 219 and 220 and part of lot 218 of Cottage Grove as recorded in Plat Cabinet A, slide 145 as depicted in Exhibit rights over, across and incorporates herein by reference, is hereby vacated, subject to easement Lakeview, Ohio for Village purposes.
